Rules and regulations

Entries must be received by Wednesday, April 8th, 2020. Entries by e-mail or regular mail and limited to 125 entries. Late entries may be accepted with a \$10 late fee at organizer's discretion. No refunds. To verify entry and for category changes, please e-mail sussexhda@outlook.com

Age as of April 18, 2020. Age categories will be determined by number of entries. Special events will not count towards high aggregate awards. There is a \$10.00 penalty fee for dancers without their registration card. Dancers must be in full costume including ghillies to receive their awards. Prizes: medals and trophies will be awarded in all categories except Primary where only medals will be awarded.

Judging: Dancers will be judged according to the techniques of the R.S.O.B.H.D. Judge's decision shall be final. There will be no access to judge's score sheets. In the event of a protest, a \$25.00 non-refundable fee must accompany a written complaint and be submitted to the organizers the same day as competition.

The Sussex Highland Dance Association will not be responsible for any injuries, accidents or lost articles to competitors or spectators.
