Age as of April 4, 2020. Age categories will be determined by number of entries. Special events will not count towards high aggregate awards. There is a \$5.00 penalty fee for dancers without their registration card. Dancers must be in full costume including ghillies to receive their awards. Prizes: Medals and trophies will be awarded in all categories except Primary and Special Events.

Judging: Dancers will be judged according to the techniques of the R.S.O.B.H.D. Judge's decision shall be final. There will be no access to judge's score sheets. In the event of a protest, a \$25.00 non-refundable fee must accompany a written complaint and be submitted to the organizers the same day as the competition.
